#### 4. Expressions of Interest\*

1. Recommendation: That the Clubs Committee approve the Expression of Interest submitted by the proposed Transparency

Billy: No social focus.

Katherine: Sounds like a person not in students politics, seems like an open dialogue with student politics rather than a Club.

Billy: Do we need to supply the name so that we can pass onto SRC?

Katherine: Do we not do this already? Trying to increase transparency within the Club spectrum.

Luke: Not in favour of this.

Katherine: Maybe they want to get to know people in students politics personally, but do the Club need to do that? Pushing boundaries with them.

Kate: Inappropriate assumption that paid staff will do this for them. But our job is not to report back into a Club.

On Dit operates within this space, and the individuals can reach out to people if they have any concerns regarding transparency.

Motion fails.

2. Recommendation: That the Clubs Committee approve the Expression of Interest submitted by the proposed Adelaide Uni MMA

Katherine: Sounds fun and seems social.

John: Does it come under sports?

Luke: Mentions the Judo Club – that falls under Sports.

Simone: Used to be two clubs co-existing, in AUU and Sports. The AUU one had more of the socialisation aspect, whereas the other one was more focused on different disciplines.

John: MMA not a social sport since high risk of injury.

Luke: Suggest they are a better fit for AU Sports but if you are unable to register with them, come back and we can deal with them.

Recommendation: That the applicant communicate with AU Sport.

Katherine: Not real money but practicing virtual trading.

Luke: 'Tracking imaginary profits'.

John: Do we ask them to talk to Finance Society?

Billy: The Finance Society seems more faculty-connected, than an interest.

Katherine: Does it sound like a lie? Making it sound like resume-padding. It could be okay but it is a weird name.

Luke: Avenue from a commerce stream.

Katherine: Name sounds like they are using real money. Maybe Adelaide Student Virtual Trading Club?

John: Suggest they change the name.

Billy: We approve it with the caveat that they change their name.

Billy: There is a Club for it at Sydney Uni. If it isn't limited to the one event, opposed to it, but if it year-round seems fine.

Luke: They are persistent.

Kate: We know we have a large cohort of Chinese Students.

Kate: I had already told the Club to get in touch with AU Sport. They would not be able to operate on campus.

Luke: I think if they can't get through with AU Sport, get them to get in touch with us.

Kate: Activate Student Ministry might also be Catholic, but they are more focused on International students.

Billy: Another Christian Club to use up all the grant funding. In the University, they have a Catholic priest, Protestant priest, etc. but with one person definitely a Catholic. Are these Clubs working together?

Luke: But is that different from saying the Chinese Students Association cannot exist because we have the Confucius Institute on campus?

Kate: Suggestion to see the priest first, and then try and gain the 10 people in the IGM process. Better approving more.

Luke: If they cannot find ten people, then they will not pass provisional registration stage.

Moved: Luke

Seconded: Billy

Motion carries.

8. Recommendation: That the Clubs Committee approve the Expression of Interest submitted by the proposed UoA In Unison Acapella Society Louise is present on behalf of AUCS.

Katherine: We do not want to have two of the same Clubs, since I have heard that it is hard for Choral Society to fill spots.

Louise: I imagine they will have the same issues we do, that they will struggle to find the people. Not exactly the same subset of people, so we put in our letter that they do not put their rehearsal on the same night we always do it.

Luke: Is there room for acapella in your society?

Louise: We have specific concert repertoire, which will include some acapella songs. They are not mutually exclusive, because we do have people interested in joining something like this.

Simone: If you had members joining you only wanting to do acapella?

Louise: They would not be able to do that. They could propose that we do that as a certain concert for one semester, but that is all.

Moved: Billy Seconded: Katherine

Motion carries.

9. Recommendation: That the Clubs Committee approve the Expression of Interest submitted by the proposed Adelaide MedTech Hackathon Katherine: Still do not think this is a Club, this is an event.

Luke: I like what they are doing. This would be a constructive outlet to meet similar minded people.

Katherine: It takes away opportunities for other Clubs.

John: If ThincLab is supposed to be funding it, why do they require YouX Clubs funding?

Luke: In the email, they mentioned they have already worked with other societies. If we provide a Club that gives links to ThincLab. I am really keen on the idea.

Katherine: I am not convinced, but I would happy if they come into to a meeting.

Kate: They might not work under a Clubs structure, and maybe they just move on after a year.

John: People from ThincLab not necessarily from the University of Adelaide.

Kate: What if the Club is a MedTech Club?

Luke: If you take away their name, then you are removing their major purpose.

Kate: The person is very persistent.

John: They are sponsored by ThincLab rather than affiliated.

Moved: Luke, John Dissent: Billy, Katherine

Motion carries.

Billy: Circular resolution to approve once they have had their meeting.

Kate: Not a new EOI if they wanted to keep going with the Club.

Kate: The easiest thing to do is have Clubs Admin email them and ask how they are any different from EFE.

Luke: Leave it pending and see if they come to some sort of agreement with themselves.

Kate: We will share their contact details if they want to work together.

#### Add new section 5.10

#### 5.10 Conduct of attendees

5.10.1 Attendees shall address remarks to the Chair in restrained and courteous language, speak relevantly to the matter under discussion, not use offensive or objectionable language, not behave in a disorderly manner, and shall respect the authority of the Chair at all times. 5.10.2 The Chair may name any person who acts in this section or is otherwise disruptive,

5.10.2 The Chair may name any person who acts in this section or is otherwise disruptive, and this shall be recorded in the minutes.

5.10.3 Any person named three times during a meeting must not be recognised by the Chair and must immediately leave the meeting.

Billy: There would like to be a way that the Chair can ensure there is no chaos. I have taken some words from the SRC Constitution which crosses over significantly with the YouX Constitution about the conduct of attendees. Does not currently contain the power to name and remove attendees.

Luke: Three might be too much almost, surely just one works. Three disruption from ten people is thirty disruptions.

Billy: Three and you're out pretty much standard across governance documents.

Luke: I agree with elements like Board Directors being able to attend, but the function of Clubs Committee is different to any of the other governing bodies.

Billy: No warnings?

Luke: One warning.

Billy: So we would change it to name twice.

Luke: It maintains a civil atmosphere, or guarantees one.

John: Should we have 5.2?

Billy: I think it is the most important part of it, and the spirit of having Presidents here to witness proceedings. But I think putting that in the policies is the spirit of the whole amendment.

Luke: If the conflicts can be noted before the meeting kicks off.

John: The only problem is that if sixty Presidents come, it would be too difficult to navigate the conflict of interests.

Luke: Since we are not discussing issues to students, not as relevant to all students.

Kate: Might be hypothetically if we have fifty all Zooming ... we might not be comfortable having so many people in this space. On the Chair to manage as we go.

Luke: Should we formalise it to add a caveat of outrageous numbers of people?

Billy: The Board did not have to do that during COVID times. At the discretion of the Chair to send a Zoom link.

Luke: Does the policy make that clear? If I were a new chair, I would not be aware. I would assume fifty people would be allowed to be there.

Kate: This would be the number expected. But as the chair, at some point in the future, you will have to say, at this point of time, we are only allowed fifteen people in the room.

Katherine: With the larger meetings, there was a lot of contention and there was a reason why all the Presidents were in the meeting. It was not a general meeting. If there was an anticipation, might not be the same.

Luke: Happy with it, just amend to the person named two times.

Billy: I think it covers new EOI applicants. Should we add Presidents or the designated proxy?

Luke: Leave as it is.

Billy to send the edited amendments to the Clubs Committee.

Recommendation: That the Clubs Committee will approve the submitted proposed amendments to the Committee Rules, with the noted amendments. Moved: Billy Seconded: Katherine

Motion carries.

8.1 Recommendation: That the Clubs Committee freeze the Adelaide University Monarchist Society.

Kate: They are uncontactable, they have not set up a Facebook. They have not been registered since late 2021.

Moved: Billy Seconded: Luke Motion carries.

Luke: Wanting to bring up Presidents Dinner. Is it the best use of funds?

Billy: I am the biggest supporter of the dinner. Out of principle, will be very bad for the Clubs community.

Kate: It is the only high expense event we run for Clubs. But in terms of rewarding those volunteering hundreds of hours.

Luke: Can we add as a discussion item for the next meeting?

Simone: I know the events team are already working on this. Maybe see in a feedback survey.

Katherine: Having it somewhere on campus.

Luke: But will discuss at the next meeting. Not even discuss for this year necessarily, but just to talk about.

Simone: I will check in with where they are at.

Luke: I also wanted to bring up that I am on the Student Engagement Committee, and they have SSAF funding that they want to dispose of. They are looking for ways to use this. I thought Clubs would be a great means for this. But rather than adding to the Clubs budget, perhaps we want to tailor it to a specific sort of criteria that the University can look at. They can see the results. We've got a bit of the time to think about, next meeting we can have a bit of a proposal.

Kate: If you get anywhere, if you could let us know what you are thinking, because administratively, we will have to consider how we will roll it out.

Luke: If we aim to have a meeting and discuss these things.
