1. Meetings With the EO

I have met with Gary and discussed various issues.

## 2. Merger Discussions

I have met with Professor Jennie Shaw and Martin McCarron to discuss the proposed merger of the University of Adelaide and Uni SA. During the discussion, the sentiments expressed in the Chancellors email to all students, principally being that the merger is purely in the investigative phase, were reiterated. I have also been made aware that a merger is likely to result in increases in state funding, something that is not the case at present. This may yield an increase in the quality of education delivery to students. I also discussed how a potential merger will affect YouX and have been informed that at present, YouX is guaranteed to continue operating as is until 2026. Due to the uncertainty and dynamic nature of the situation, the future of YouX beyond 2026 remains unknown. However, I will continue to laisse with the university and ensure that we are prepared and ready to adapt accordingly as the merger talks develop.

3. Education for a Digital World Co-Design Workshop

In the upcoming weeks I will be participating in a series of workshops wherein discussions will take place on how the university can evolve its education delivery for a digital world. The aim of these workshops will be to determine how the University can best implement the use of digital technologies in the delivery of student's education.

## 4. CRS Closure of the General

As per my email earlier, you will all be aware that the CRS board resolved to close the General. The General has been consistently underperforming in the wake of covid. It has reached the point where the losses incurred by it no longer warrant continued operation. The closure will result in a significant increase in CRS profit (from the increasingly successful Store), which in turn will flow through to YouX, allowing increased capacity to improve the YouX-perience. This increased revenue will be recognised in 2024.

## 5. SRC Activity

The SRC meeting schedules have been released for the rest of the year, with the next meeting to be held on the 8<sup>th</sup> of February. As per Georgia's report, the SRC are planning their O'week program and have been liaising with the events team accordingly.
